Entry - level positions are available with this certificate in the following areas: emergency management specialist, homeland security officer, hospital emergency preparedness administrator, emergency dispatcher, emergency medical technician, among others. According to the Bureau of Labor Statistics, projected employment change in 2010-20 for emergency management directors includes 1,600 new jobs and an expected growth rate of 13 percent, about as fast as the average for all occupations.
